- 1) The Board hereby **renews** the Consent for Operation (CFO), Hazardous Waste Authorization (HWA) & Bio-Medical Waste Management (BMWM) Authorization of the Common Bio Medical Waste Treatment Facility (CBMWTF), issued vide reference 1<sup>st</sup> cited along with amendments issued vide references 2<sup>nd</sup> cited, **for a period up to 30.06.2026**, under Section 25/26 of the Water (Prevention and Control of Pollution) Act 1974, Section 21/22 of the Air (Prevention and Control of Pollution) Act 1981 & Environment (Protection) Act 1986 and Rules made there under, Authorization under Rule 6(2) of the Hazardous and other Wastes (Management & Trans-boundary Movement) Rules, 2016 & amendment thereof and under Rule 10 of the Bio-Medical Waste Management Rules, 2016 & its amendments thereof.
- 2) This order is issued under **Auto Renewal System** of the Board as per the circular issued vide reference 3<sup>rd</sup> cited and as per the self certification submitted by **M/s. Roma Industries, Sy.No. 103, Thokkapur (V), Bhongir (M), Nalgonda District**, vide reference 5<sup>th</sup> cited. All the conditions stipulated in CFO, HWA & BMWA order dt.08.06.2016 which is valid up to 31.05.2021 and amendment orders dated: 27.08.2018 will remain same. The Board reserves its right to review, modify, revoke conditions and vary the validity period of the CFO, HWA& BMWA of the CBMWTF.
- 3) In case of any false certification, non-compliance of conditions / directions and deficiency in furnishing the information by the Facility, the Board can withdraw the Auto Renewed Consents & Authorizations and take action under the provisions of relevant Acts & Rules including forfeiture of the Bank Guarantee submitted by the Facility for Rs.25,000/- vide BG No. 003872IBG0000013, dt.30.04.2021 with validity for a period of 5 years i.e., upto 30.06.2026.
- 4) Under auto renewal system, the industry shall apply at least 30 days before the expiry of the existing consent order for further renewals.
